• Interrelationship of building and surroundings: DeLauro Park is located along the north side of Grand Avenue, between Franklin and Hamilton Streets. It borders Farnam Courts, a public housing complex, that lies immediately to the north. To the south and east, the park is surrounded by street commercial buildings. To the west is the Interstate 91 highway, which separates the park from the main Wooster Square esidential neighborhood (west of the highway).	s of
• Other notable features of building or site (Interior and/or Exterior) DeLauro Park is a roughly rectangular park that contains three clearly defined sections connected by a central walkway: a olayground, a strolling and seating area, and a gathering place. A circular poured-concrete wall, with a pattern left by woode ormwork, creates segments of a circle and delineates a sunken playground space at the east end of the park (new play structures added c. 2000); the circle is completed by three steps (original) and a contemporary iron fence. A three-quarter-ci concrete bench creates a continuous seating area at the west end of the park. This seating area is reminiscent of a council f a popular aspect in early twentieth-century parks that was used as an intimate, friendly gathering place for visitors. Grassy batches are present in the center of the park and contain intermittently-placed round concrete tables and stools. Sycamore tare planted throughout, and in addition there are basswoods in the eastern play circle and honey locust trees along the streat he eastern edge of the park. Architect Landscape - Dan Kiley Builder	
 Historical or Architectural importance: Built in 1971, DeLauro Park was part of the New Haven "playground modernizate program" which placed numerous parks on designated lots in commercial-industrial as well as residential sectors of the city. Named after Ted DeLauro (1902-1971), a prominent citizen of the Wooster Square area, the site was proposed as a public plas early as 1952. In her guide to New Haven architecture, Elizabeth Mills Brown stated, "DeLauro Park [was] the most elabor of the distinguished series of pocket playgrounds which the Redevelopment Agency has been putting on vacant lots around New Township." Aesthetic decline has plagued the park for many years, resulting in plans for condition improvements through the 1980s and 1990s. Renowned landscape architect Dan Kiley designed DeLauro Park, and incorporated concrete details continue to lend a Modernist quality to the park. Round concrete tables and stools are a distinguishing feature (see Kiley's n enzi Park, 1970). Kiley (1912- 2004) is known for his Modernist landscapes, particularly for such large-scale projects as the lefferson National Expansion Memorial in St. Louis and the South Garden at the Art Institute of Chicago. Here the abstract geometry of the landscape elements and site furnishings act in counterpoint to the natural plant materials. 




4. View of western circle from Grand Avenue, camera facing north.
