• Interrelationship of building and surroundings: The building sits at the end of a large pier extending into New Haven Harbor. Docks and boatyards are located adjacent to the pier, while the surrounding City Point (or Oyster Point) neighborhood is residential. The architecture in the area is a mix of 19th-and 20th-century construction and the immediate area is a Local Historic District.
• Other notable features of building or site (Interior and/or Exterior) The building at 100 South Water Street consists of 2 adjoining rectangular wood-framed blocks, with grade beam foundations on wood piles. The narrower north portion is 1-story and has a shed roof sloping up to meet the vertical wall of the 2-story south block, which has a higher shed roof sloping down toward the south. The building is clad in vertical grooved plywood siding (T-111) with corner board trim and a belt course at the floor level. Clerestory windows in the north wall of the south block are in a horizontal band above the high point of the north shed roof. The roof covers the building's recessed entry at the northwest corner of the north block. The 1st story of the south block is filled with continuous windows, looking south to the water views. The 2nd story roof extends over a porch running the length of its southern (rear) elevation, also above an exterior 1st floor deck. Like the 1st floor, the exterior walls of the 2nd floor are filled with windows, providing unobstructed views of the harbor to the south. A massive chimney projects from the south roof plane, off-center toward the east, signaling the location of a fireplace inside. Architect William L. • Historical or Architectural importance: Built in 1974, the Chart House Restaurant was the first of a multitude of planned developments targeted at revitalizing New Haven's waterfront spaces at City Point in the Hill neighborhood. Situated on a pier extending into the New Haven harbor, the restaurant was one of a national chain which served steak and seafood dishes. The main dining room accommodated 180 guests while an additional second level held a lounge and bar overlooking a portion of the first floor. The restaurant's location, adjacent to the Point West Marina, emphasized its maritime fare as well as the city's historical connection to Long Island Sound. The restaurant continues in operation as Sage American Grill, with the Pequonnock Yacht Club occupying the second floor. With its 2 juxtaposed sheds forming angular abstract forms evoking fishermen's shacks, the building represents a California Modernism of the type exemplified by Sea Ranch.




